Hence, after sanction from DFO, RAAYUR BHANJ about growth of tree. This is to be finalized. This is for information and necessary.

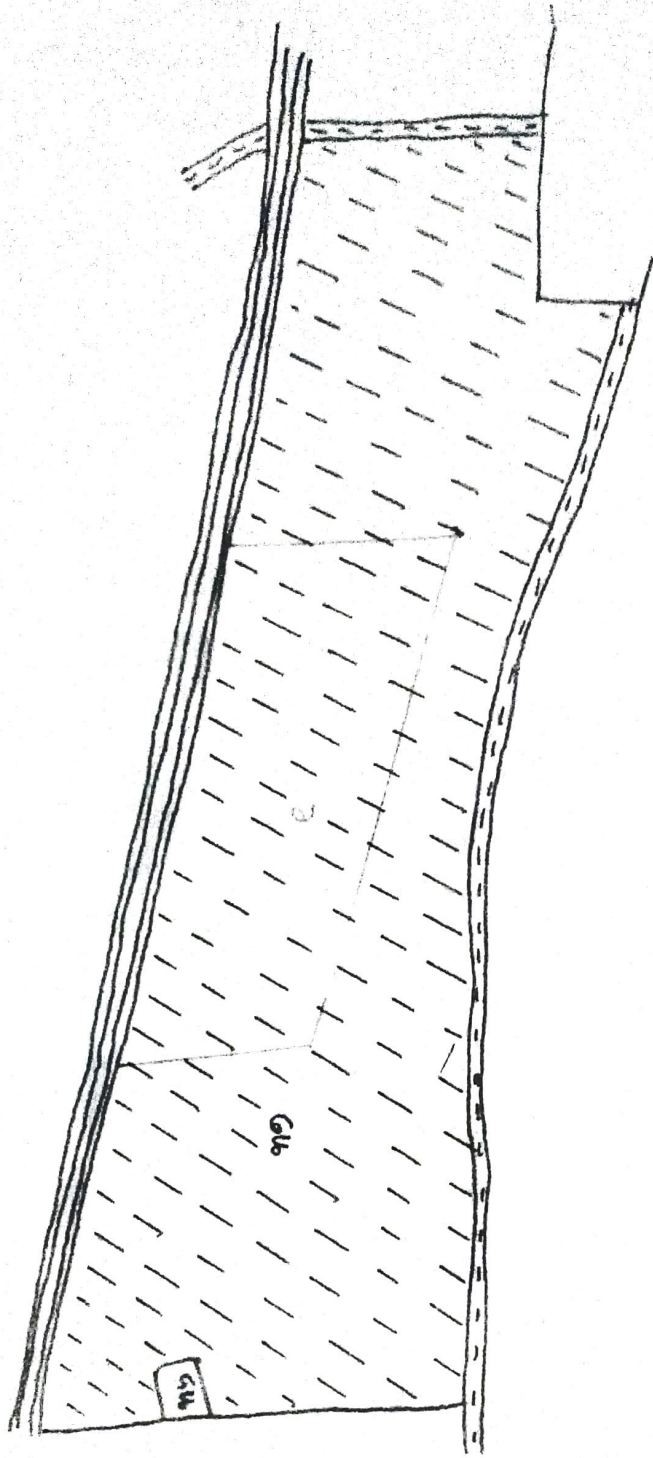
